Order under Section 144 Cr. P.C.

WHEREAS, the Election Commission vide Press Note No. ECI/PN/83/2021, dated 28/09/2021 declared the schedule for Bye- election for 86-Santipur Assembly Constituency and the Counting process for the said Election will be held on 02.11.2021 for 86-Santipur Assembly Constituency of Nadia District at the following Venue Ranaghat College, Ranaghat, Nadia falling under at Ranaghat Police District of Nadia District.

AND WHEREAS, there is every reason to believe that unknown miscreants may create disorder and trouble in and around the Counting Venue premises mentioned above, which may hamper the process of conducting Counting process in free and fair manner;

AND WHEREAS, it appears that such action of the miscreants may also cause breach of peace and public tranquility in the neighborhood of the Counting Venue;

AND WHEREAS, it appears that there is sufficient ground for proceeding u/Sec. 144 of the Code of Criminal Procedure, 1973 for prevention of such nuisance or apprehended danger.

NOW THEREFORE , I, Shashank Sethi, I.A.S., District Magistrate, Nadia, in exercise of the power conferred upon the undersigned u/Sec. 144 Cr.PC, do hereby direct the following in the entire premises of Ranaghat College, Ranaghat, Nadia falling under Ranaghat Police District of Nadia District for the period from 06:00 A.M of 02.11.2021 till completion of Counting process.

1. There shall be no Assembly of 5 persons or more within 200mts. periphery from the boundary of the Counting Venue premises.
2. The owners of houses and other establishments within 200mts. periphery from the the boundary of the Counting Venue premises shall not allow any unauthorized persons to Assemble in their houses and establishments.
3. Nobody shall carry firearms, other weapons, lathis etc. within 200mts. periphery from the boundary of the Counting Venue premises.
4. There shall be no parking vehicles near gate of the Counting Venue premises.
5. Microphones, loudspeakers etc. shall not be used in the vicinity of Counting Venue premises (within 200mts. and beyond) in such a manner that it hampers the process of Counting process.
6. Any other activity which may disturb the process of Counting shall remain strictly prohibited within 200mts. periphery from the boundary of the Counting Venue premises.

This order shall, however, not apply to the officials engaged in the enforcement of Law and Order, conduct of Election and maintenance of essential services.

Any persons violating the order shall be punishable u/Sec. 188 of Indian Penal Code.

The order is being issued ex-party u/Sec. 144 (2) Cr.PC.

The Superintendents of Police, Ranaghat Police District are requested to communicate this order to the Inspector-in-Charge and Officer-in-Charge of the Police Station of his jurisdiction with a direction to implement the order.


