In exercise of the power conferred by sub-section (1) of section 98, of the West Bengal Panchayat Act 1973 (West Bengal Act XLI of 1973), read with Rule 2A of the West Bengal Panchayat (Constitution) Rules, 1975, I, the District Magistrate and District Panchayat Election Officer of the district of Nadia, for the purpose of reconstitution of the Panchayat Samitis following the next General Elections hereby determine, after previous publication of the draft of this order as required under the said rules, for the offices of Sahapati / Sahakari Sahapati of the Panchayat Samitis within the district, as specified in column (1) of the Schedule below, the total number of offices in the district specified in the corresponding entries in column (2) of the said Schedule, the number of offices in the district reserved for Scheduled Castes, the Scheduled Tribes, Backward Classes and Women members specified in the corresponding entries in column (3a), (3b), (3c) and (3d) respectively of the said Schedule, the offices reserved for the Scheduled Castes(SC) or the Scheduled Tribes(ST) or Backward Classes(BC) specified in the corresponding entries in column (4), and the offices reserved for Women specified in the corresponding entries in column (5) of the said Schedule.
