| FORM 6 | <p>1. First time application on attaining age of 18 years or more on the 1st day of January of the year with reference to which the electoral roll is being revised.</p> <p>2. Person shifting his/her place of ordinary residence outside the constituency in which he/she is already registered</p> <p>3. This form is available at all designated locations at the time of Special Revision Programme and at ERO's Office during Continuous Up-dation programme.</p> |

| Form 7 | <p>Can be filed only by a person whose name is already included in that roll in order to object inclusion of a name proposed to be included in that part of electoral roll or for seeking deletion of a name already included in that part of the electoral roll.</p> <p>The application can be filed after draft publication of electoral roll of the constituency to object to the proposed inclusion of an entry in the draft roll. The application is to be filed within the specific days provided for the purpose. The application seeking deletion of an entry from the final Electoral Roll can be filed throughout the year even when the revision programme is not going on. During revision period, the application can be filed at the designated locations where the draft Electoral Roll is displayed. During other period of the year, the application can be filed only with the Electoral Registration Officer .</p> |

| Form 8 | <p>Can be filed by a person whose name is already included in the Electoral Roll seeking corrections to her/his particulars already printed in the Electoral Roll. It can be filed after draft publication of the Electoral Roll of the constituency at designated locations within the specific days provided for the purpose during revision programme. During other period of the year when revision is not going on the application can be filed with the Electoral Registration Officer .</p> |

| Form 8A | <p>A person whose name is already included in the current Electoral Roll can file the application for transposition of an entry in a different place of the same constituency. The application can be filed after draft publication of Electoral Roll of the constituency for transposition of entry within the same constituency. The application is to be filed within the specific days during revision programme and during other period throughout the year when the revision programme is not going on the application can be filed only with the Electoral Registration Officer .</p> |

| 001C | <p>Can be filed with two recent colour passport size photographs by an elector whose name has already been enrolled in the concerned part of the Electoral Roll but EPIC has not been issued . Can be filed by the electors whose name has been enrolled in the Electoral Roll but failed to attend the Photo Capturing programme fixed by the Electoral Registration Officer/ Asstt. Electoral Registration Officer . 1</p> |
