

MINUTES OF THE MEETING OF DLVMC HELD ON 29.06.2012 IN THE
MEETING HALL OF NADIA ZILLA PARISHAD AT 11:00 A.M.

The list of participants enclosed separately.

In absence of the Chairman, DLVMC, Nadia the Sabhadhipati, Nadia Zilla Parishad took the chair.

As the instance of the Chairman, DLVMC, Nadia the Additional Executive Officer, Nadia Zilla Parishad initiated the formal discussion. Following this there had been deliberation on each agenda and all the members took active parts.

The out come of the deliberation are:

IAY:

There had been good deal of progress but there had been also a few instances of score manipulating. All Panchayats are required to check the scores of the beneficiaries meticulously so that no score jumping occurs at all.

Action: AEO, NZP

PMGSY:

The progress work of 12 nos. of roads was going on, out of which progress of Banpur PWD Road to Malighata work was very poor due to non-availability of borrow pit earth and encroachment.

The work of following 3 (three) nos. packages had not yet been started. The Agency established laboratory at the site and due to non-availability of borrow pit earth and encroachment the work could not be started.

- a) Baraipara Chhutarbari More to Ramnagar.
- b) Kablikhali to Kustia
- c) Mohanpur to Mohanpur Bazarpara

For the following 2 (two) nos. packages, no bidder attended in 2nd call, the 3rd call would be invited very soon from WBSRDA, Kolkata.

- a) Hatkhola Uttar to Baraandulia Dakshin under Chapra PS.
- b) Dompukur Paschim to Hatkhola Dakshin under Chapra PS.

For the following 3 (three) nos. package of Ph-VI, no bidder attended on 8th call.

- a) Chakdaha to Uttar Ghugia-Chakdaha PS.
- b) Elangi to Mohakhola-Chapra PS.
- c) Hatubhanga to Kamdanga-Ranaghat-II PS

File had been initiated by WBSRDA, Kolkata to Government for awarding the packages to the reputed firm viz. Saxby Farmar, Makintosh Burn Ltd. Etc.

Necessary legal action against the contractors of the terminated schemes must be taken.

Action: AEO, NZP

NREGS:

There had been no dearth of fund. The wage and material ratio (60:40) should be followed properly in all the cases.

In Bethuadahari-II Gram Panchayat under Nakashipara Development Block there had been a case where double payment was made for earth cutting / filling of a pond.

Action: DNO, NREGA

NSAP:

A good number of beneficiaries who received pension under erstwhile NOAPS were not getting pension at present. Detail information of such beneficiaries from all the Blocks had not been received.

The defaulting Block Development Officer would be requested to send such information within 20th July, 2012, if failed, it would be presumed that they have no such beneficiaries. The available reports would be compiled and sent to the Government by 30th July, 2012 for taking necessary action.

Action : DP&RDO, Nadia

TSC :

It was pointed out that all Primary Schools did not have latrines. Those had latrines were mostly very dirty. For this reason the concerned GPs were not selected for Nirmal Gram Puraskar. Headmasters / Headmistresses of such schools should take special care on this score.

The arrangements of water near the latrine of the schools should also be made out of Untied Fund. The representative of Sri Tapas Pal, M.P., assured to provide fund on specific proposals for such water arrangement, if received.

A new scheme i.e. TSC dovetailed with NREGS plus contribution of the beneficiary was going to be launched shortly.

There has been a proposal to provide latrine to all un-covered homes and schools by 2015.

Action : AEO, NZP

BCW:

The contractor who failed to complete the work in kitchen shade of Vidya Mandir, Chitrashali should be terminated. Fresh tender needed to float with revised estimate. There had been complaint against the Inspector (under BCW) of Nabadwip. It was requested to take necessary action.

Action : DWO, Nadia

There had been a request to provide the Booklet prepared for the meeting well in advance for study, for the next meetings and onwards.

While summing up, the Sabhadhipati, Nadia Zilla Parishad expressed grief over the poor attendance of the honourable members of the committee.

He also told that, as desired by the members guide lines of the schemes dealt by the committee, had been provided to all the members for study in earlier meeting.


Teams would be formed for visits different Blocks to verify whether the schemes were being implemented according to norms.

Accordingly, 5 (five) teams would be constituted for equal visits of the 5 Blocks as under. The teams are required to submit reports to the District Magistrate, Nadia within 2 (two) days of the visit which would be discussed in the next meeting of DLVMC.
