ORDER

In pursuance of Gazette Notification No. 1368/PN/O/III/2A-18/2002 dated 23.03.2007 of Principal Secretary to the Government of West Bengal, Panchayats & Rural Development and this office Employment Notification No. 1069/P&RD/DLSC, Nadia/2016 dated 05.12.2016, the candidates mentioned in Column (2) of the **enclosed list**, who have been provisionally selected on the basis of the result of written test and viva-voce held for the post of "**Secretary**" in Gram Panchayats under Nadia District are hereby **appointed on a purely temporary basis, as per bond executed by each candidate, for a period of 6(six) months to the post of "Secretary"** in Gram Panchayat mentioned in Column (5) with effect from their date of joining in the Scale of Pay as revised in PB-2 of Rs. 5400-25200/-(entry point pay-Rs.6240/-) plus grade pay of Rs. 2600/- as per W.B. ROPA Rules 2009 plus other allowance as admissible under Government Orders issued from time to time. This temporary appointment is offered subject to following terms and conditions-

- (1) The charge on account of the grant sanctioned above will be met from the provision under the head of account, "2515-00-101-NP-004-Contribution towards salaries of the employees of Gram Panchayats (PN)-V-31-Grants-in-aid-GENERAL-01-Salary Grants" from the Budget of the Department of Panchayats & Rural Development, West Bengal under demand no. 40.
- (2) The Antecedent Roll (Verification Roll) shall be sent to the concerned Superintendent of Police for verification and this temporary appointment is subject to immediate cancellation due to receiving of any sort of adverse report in verification roll.
- (3) They will be liable to be transferred anywhere within the district of Nadia.
