No. 2425(3)-MD/0/2M-89/09(Pt II) dt. 30.12.2013 of the Secretary to the Govt. of West Bengal, Minority Affairs & Madrasah Education Department, Guest Teachers shall be recruited for Paninala English Medium Govt.
