Sealed Tenders are invited from the bonafide, prospective, eligible & reputed concern to supply one Biometry Machine & one Keratometer as per specification attached. The said Machine with its accessories should be supplied at DRS at C.M.O.H, Nadia.

## General Terms & Conditions

- 1.The Tender documents must be in two parts. 1<sup>st</sup> part-Technical Bid documents, 2<sup>nd</sup> part-Financial bid Documents. Both the said two bid documents must be submitted with a cover letter mentioning the type of bid document addressed to the CMOH Nadia.
- 2.The Tender documents must be submitted with related documents in the sealed cover super scribing "Application for Supply of one Biometry Machine & one Keratometer" as specification attached herewith only addressed to the Chief Medical Officer of Health, Nadia, 5 D.L.Roy Road, P.O.-Krishnagar, Dist.-Nadia, Pin-741101, West Bengal within 5 P.M. on 20.6.2012. Bid documents will be submitted in any way. The authority will not be responsible for any postal delay.
- 3.Only capital letters should be used in filling the Tender format. All papers submitted with the Tender papers shall be serially numbered and signed by the Tenderer.
- 4.Erasures, over writing and deletions shall be avoided. Rates should be written neatly both in figures and in words. The rates should be quoted for biometry machine & Keratometer separately. The Tender documents shall be submitted under covering letter mentioning the total number of pages. The cover containing the tender must contain the name and address of the tenderer.
- 5.In case of the acceptance of the tender documents, financial bid will be considered only after successful completion of the technical bids.
- 6. The Tender documents will be opened on 21.6.2012 at 10.00 A.M. at the office of the Chief Medical Officer of Health, Nadia, 5 D.L.Roy Road, Krishnagar, Nadia, Pin-741101.If the Office happens to be closed on that day for any reason whatsoever, then the tenders will be opened on the next working day.

- 2.Large display(320X240 PLCGD with CCFL Black Light)
- 3. IOL power calculation formula.

- 5. Printer-high speed Thermal Printer-various user programmable print out format.
- 6.Measurement: Resolution-0.01 mm. measurement-manual/Auto, measurement accuracy+ or -0.1 mm. Axial length Measurement-15 mm to 38 mm audible signal. Simultaneously shows axial length, anterior chamber depth, lens thickness and A-Scan waveforms in real time.
