

Sealed tenders are invited from the bonafide owners of vehicles with commercial registration as mentioned below for providing the same on hire basis to be used for carrying planting materials from State Horticulture Res. & Dev.Station,Krishnagar/CADC-Aranghata/KVK- Gayeshpur/CADC-Haringhata to different Gram Panchayets of different blocks of Nadia district as per following terms and conditions.

- 1 The rate should be offered per kilometer for carrying 1200 saplings per Vehicle (including fuel & all other charges).Rate is to be quoted both in words and figures.
- 2 Vehicle is to be provided along with the driver at the required time.
- 3 The owner of the Vehicle will provide three (3) labourers with his vehicles for loading & unloading saplings.
- 4 The contract will be completely in temporary in nature
- 5 Maintenance/repair of vehicle, payment of all tax etc should be made by the owner of the vehicle.
- 6 One printed log book should be maintained by the driver with authentication of the undersigned
- 7 Mobile set should be provided to the driver by the owner of the Vehicle.
- 8 All papers of the vehicle like copies of tax clearance, pollution certificate, fitness certificate, registration certificate etc to be produced along with the tender.
- 9 Clearance of income tax and P.tax should be submitted with the tender.
- 10 A declaration in this respects to the above terms and obey the above terms and conditions in non judicial stamp paper of Rs 10 only should also be submitted with the tender.
