Notice Inviting Tender for
Supply of Tissue Culture Banana

Notice Inviting Tender for supply of Plants as indicated below is hereby invited from interested Firms/Companies as per the terms and condition indicated below.

Plants to be supplied:

Hardened (both primary and secondary) banana plantlets developed through tissue culture, not less than 1.5 feet height; species wise quantity as listed below:

Terms & Condition:


- (i) Eligible suppliers should apply for tender papers which will be available in the office of the District Nodal Officer, MGNREGA Cell, Administrative Building, 1st Floor, Room No.- 212, Krishnagar, Nadia, **by 2nd August, 2012 upto 3.00 P.M.**
- (ii) Last date of issuance of tender paper from the office of District Nodal Officer is **2nd August, 2012 upto 5.00 P.M.**
- (iii) Rates are to be quoted in the tender papers only, not on plain paper or letter head.
- (iv) **Last date of dropping tender paper is 3rd August, 2012 upto 3.00 P.M.**
- (v) Filled in tender papers properly sealed are to be dropped by 3rd August, 2012 upto 3.00 P.M. in a separate Tender Box which will be kept in the office chamber of the Additional District Magistrate (LR), Nadia.
- (vi) Willing tenderers may remain present at the time of opening of the tenders which will be held in the chamber of Additional District Magistrate (LR), MGNREGA, Nadia on 3rd August, 2012 subsequently after 3.00 P.M.
- (vii) Papers of (a) proof of Trade License with current validity (b) copy of IT return or clearance for the last one year (c) Copy of PAN (d) VAT registration certificate (e) P. Tax registration certificate (f) P. Tax Challan upto date (g) Audited Balance Sheet for last three years (h) Turn over at least Rs. 10 lakh per annum for last three years (i) Credential Certificate in the form of Payment Certificate of similar nature of work at least Rs. 05 lakh

Sector Units (PSU) (j) relevant documents in support of having technical facilities /personnel and financial position (k) copy of valid certificate from the Department of Bio-technology, Govt. of India for production of quality tissue cultured plant in the existing laboratory, shall have to be submitted at the time of application for tender papers.

- (viii) Tender paper will not be issued to those applicants who will fail to submit the above mentioned documents.
- (ix) Only firms/companies having technical expertise and sound financial condition will be eligible.
- (x) Firms / Companies having credential of previous supply to any Govt. Organisation/ Office are eligible to apply.
- (xi) Only firms/companies having their own Tissue Cultured Laboratory should apply.
- (xii) The successful tenderer shall be required to start the development of banana plantlets within a month of getting order.
- (xiii) No payment will be made if the saplings are not properly hardened.
- (xiv) The plantlets shall be raised and delivered under pathogen/disease-free condition.
- (xv) Initially 40% payment will be made on supply of saplings to respective PIAs and rest 60% payment will be done on successful stand at field after 3 months.
- (xvi) If 80% or more of saplings can survive then it will be considered as stand.
- (xvii) If stand fails, payment of saplings will be made on decreased rate and payment will not be done in case of less than 40% stand.
- (xviii) Control plot to be created having drawn sample randomly and cultivated at Bunglows of District Magistrate and Additional District Magistrates in presence of the public representative, supplier and Govt. officers. Inspection of control plot to be done by a committee comprising District Horticulture Officer, Programme Officers, Sabhapatis and supplier.
- (xix) Programme Officer, MGNREGA & Block Development Officer will certify the stand.
- (xx) Delivery of the plant shall be made at the various Gram Panchayats in the district Nadia.
- (xxi) Earnest money of Rs. 50,000/- in the form of bank draft payable *in favour of District Magistrate & District Programme Coordinator, MGNREGA, Nadia payable at State Bank of India, Krishnagar Branch*, shall have to be submitted along with tender in the envelop. The earnest money will be converted to security in respect of successful and shall be returned to the unsuccessful offers on completion of the tender process.
- (xxii) The hardened plantlets shall be supplied at the planting sites (as intimated by the PIAs) by the tenderer through his/her own arrangements.
- (xxiii) Payment will be released based on the supply made after inspection by the authorities and certification of the quantity and quality of plants supplied. Any saplings, which are not as per specifications, shall be rejected and no payments shall be made for the same.
- (xxiv) The tenderer shall have to bear all tax/duties/levy, as per rules in force, of his/her own, which should be kept in a separate bank account. The offer shall be valid for a period of 90 days from the date of submission of the tender.

(xxv) The rate of plant quoted in the tender form shall be inclusive of all taxes/levies and expenditure to be included by the supplier including transportation, plantation at site.

(xxvi) The undersigned reserves the right to reject any or all the offers without assigning any reason.


