TENDER NOTICE

Sealed tenders are invited from bonafide owners of Mahindra Bolero/ Tata Sumo in good condition having commercial registration and contract carriage permit for providing one Mahindra Bolero/ Tata Sumo on hire basis to be used for official purpose by the Land Acquisition Section of Nadia Collectorate as per following terms and conditions :-

1. Monthly rate should be offered excluding fuel. Fuel will be supplied as per Govt. rules. Monthly rate is to be quoted both in words and figures. No other charges apart from the hiring charges will be given to the successful tenderer.
2. Vehicle may have to be provided on Sundays & Holidays as well and hours of duties are not restricted to any specified time.
3. Residence of driver should be within a radius of 1 K.M. from this office.
4. Monthly contract is limited to one year and may be renewed on satisfactory service. The contract will be completely temporary in nature and may be terminated on one month's notice.
5. Maintenance of vehicle, payment of all Tax, etc. should be made by the owner of the vehicle.
6. Repair works, if required, on any day should be done with prior approval of the Special Land Acquisition Officer, Nadia and one vehicle of same type is to be provided to the office during the period of repair.
7. Driver with or without vehicle should not move at any time without seeking permission of the Special Land Acquisition Officer, Nadia and suitable driver should be provided at once, if the regular driver is not able to perform the duties due to his illness or otherwise.
8. Vehicle should be kept ready at all time for movement to any place on each day.
9. One printed Log Book should be maintained by the driver with authentication of the Special Land Acquisition Officer, Nadia.
10. The driver of the vehicle needs to possess a valid license for driving.
11. The driver should possess a mobile telephone.
12. Registration of vehicles should be within two years from the current date and preference will be given to EURO-III /BS-II Model.
13. Clearance of Income Tax & Professional Tax should be submitted with the tender.
14. A declaration in this respect to obey the above terms and conditions in Non Judicial Stamp paper of Rs.10/- [Ten Rupees] only should also be submitted with the tender.

Tender may be submitted by 28th September, 2012 upto 3:00 P.M., in the box which will be placed in the office chamber of Special Land Acquisition Officer, Nadia and will be opened on 1st October, 2012 at 3:00 P.M. Tenderers may remain present at that time.
