1. The Tender will be received on in sealed cover in the office of the undersigned on 21/03/2012 up to 2:00 PM and will be opened on the same date at 3:00 PM.
2. Tenderers will be remained present at the time of open the Tender.
3. The rate should be mentioned categorically as per their maximum period of storage of ice.
4. The selection will be made based on tallying rate with specification.
5. Specification wise sample should be produced before the selection committee on 21/03/2012 positively. In case of successful tenderer, the Sample will be refunded after two months from the date of last supply and in case of unsuccessful tenderer it will be refunded on the same date.
6. Attested copies of Income Tax & Sale Tax clearance certificate including VAT and trade license are to be submitted along with the application.
7. The tender should invariably and clearly be mentioned in the letter head pad duly signed by the tenderer. The rate must be quoted in figure and words neatly and correctly in English including loading/unloading, transportation and all other charges.

A sum of Rs. 12,000/- (Rupees Twelve thousand )only is to be deposited through Bank Draft as Earnest Money in favour of the **Chief Executive Officer, Nadia District Fishermen's Co operative Federation Ltd.** with the tender. 15. The supply must be made within 15 days from the date of receiving the supply order at the site mentioned in the supply order.


