From BOQ comparative chart, it appeared that the agency named 'Bhattacharjee Enterprise' had quoted the L1 rate i.e. Rs. 157/- (Rupees One hundred fifty Seven Only) (inclusive of all taxes and charges) per pc. Air borne Control Kit. Sri Ganesh Textile had quoted the L2 rate i.e. Rs. 159.39/- (Rupees One hundred Fifty Nine point Thirty Nine) (inclusive of all taxes and charges) per pc. Air borne Control Kit and M.L. Scientific had quoted the L3 rate i.e. Rs. 169/- (Rupees One hundred Sixty Nine) (inclusive of all taxes and charges) per pc. Air borne Control Kit.

So the tender selection committee members unanimously decided to award the contract to the L1 bidder i.e. **Bhattacharjee Enterprise** with their quoted rate i.e. Rs. 157/- (Rupees One hundred fifty Seven Only) (inclusive of all taxes and charges) per pc. Air borne Control Kit.
