During technical bid evaluation, the tender selection committee has generously dealt the matter of submission of schedule of bank accounts, submission of P. Tax (Valid for FY 2019-20), submission of declaration of MSDS/ Product safety certificate, credential of work by the bidders.

7 out of 8 bidders (except Smart Udyog) have submitted sample-copy of the requested consumables, asked vide Memo No. CMOH/Nad-9742, dated 12/12/19.

6 out of 8 bidders (except Labgills, Smart Udyog) have submitted their declaration on MSDS and Product safety certificate, vide Memo No. CMOH/Nad-1889, dated 27/02/2020.

However, as for e-tender for procurement of laboratory consumables for microscopy centres under RNTCP Nadia ref: Memo No. CMOH/Nad-6784, dated 20/08/19, 8 (eight) bids were submitted, out of which 2 (two) bids (i.e. Labgills & Smart Udyog) have been cancelled by the tender selection committee due to non-submission of Affidavit in stamp paper.
