Sealed quotations are hereby invited for the **Mango fruits (trees of different ages & variety) orchards (except Amrapali) of State Horticultural Research & Development Station, Krishnagar, Nadia.** Interested tenderer can offer price observing the following terms & conditions strictly.

**Terms & Conditions:**

(1) Superscribe the sealed envelope containing tender as “**Quotation for Mango fruits**” addressed to the Assistant Director of Horticulture, State Horticulture Research & Development Station, Krishnagar , Nadia with an **Open Demand Draft of Rupees amount (above), mention in the table as earnest money in favour of** Assistant Director of Horticulture, State Horticulture Research & Development Station , Krishnagar payable in any Nationalized Bank at Krishnagar . Quotation without the requisite earnest money will stand invalid and summarily be cancelled.

(2) Rate should be quoted both in figure and words in prescribed quotationer paper which will be available in the office of the Assistant Director of Horticulture, State Horticultural Research & Development Station, Krishnagar, Nadia during office hours and also in the **Website ( www.nadia.nic.in).**

(3) The quotationer may observe the conditions of the orchards after taking permission from the Assistant Director of Horticulture, State Horticultural Research & Development Station, Krishnagar, Nadia / Assistant Horticulture Extension Officer during office hours.

(4)The tender can be submitted duly at the tender box kept at the office of the **Assistant Director of Horticulture**, State Horticultural Research & Development Station, Krishnagar, Nadia during office hours at working days up to 1.00 pm of up to 1:00 pm 19.01.2022 and also by Postal system within the scheduled period. The tender will be duly opened on the same day 19.01.2022 at 2.00 pm, the last date of accepting tender and the date of opening may be changed to the next working day in unavoidable circumstance.

(6) **The rate should be quoted, above the minimum Govt. rate** for the said orchard (above mention table) for the mention period, if the quoting rate below the minimum govt. rate, will not be treated as valid.

(7) The earnest money of the successful quotationer will only be treated as Security Deposit and the same will be returned back after satisfactory completion of the tender period. The Security Deposit will be for fortified if any damage to Govt. property is caused due to the successful quotationer during the tender period.

(8) The successful quotationer must deposit full amount of his /her offered amount within the five working days from the date of opening the tender within 1.00 pm.

(9) The successful quotationer can collect the fruits of the orchard up to the period (specified by office).

(10) The successful quotationer has to make his / her own security arrangement during the tendered period.

(11) **Branches of any fruit tree of the tendered orchard can be utilised as scion or any other propagation works for the interest of the Govt. farm during the tender period (mainly traditional variety of mango scion like Himsagar, langra, Bombai, Rani etc.). Pruning and training of trees will also be done if required for the maintenance of the orchard during the tender period.**

(12) In case, the successful quotationer does not finally agree to pay the tendered amount within the period mentioned above the security deposit of that quotationer will be forfeited.

(13) Authority will bear no responsibility for any damage of fruits /trees due to any natural calamity /other means.

(14) Authority can impose any condition if required at any stage of the tender.

(15) The successful quotationer must inform the name and address of the persons engaged for security ( maximum 10 persons) as well as for collection of fruits during the valid period to the office of the Assistant Director of Horticulture, State Horticultural Research & Development Station, Krishnagar, Nadia. Other Persons will not be allowed within the farm. The security persons engaged by the Successful quotationer will have to abide by the rules & regulations of the office.

(16) The successful quotationer must communicate time to time with the Assistant Director of Horticulture, /respective Assistant Horticulture Extension Officer, State Horticultural Research & Development Station, Krishnagar, Nadia.

(17) The rate should be quoted above the minimum Govt. rate Rs. 2, 50000 (Rupees two lakh fifty thousand only), for the said tender of orchard for the current fruiting season up to July, 2022.
