

Tender papers will be **supplied** to the qualifying contractors on **07/07/2014 at 12.00 PM to 4.00 P.M.** The tender papers shall have to be **submitted** on **15/07/2014** in between **12.00 P.M to 2.00 P.M.** hours and the tender will be **opened** on **15/07/2014 at 3.00 P.M.** hours in presence of the renderers'.

Terms & Condition:-

1. In case of tender, rates are to be quoted both in figure and words clearly as percentage less/above/ at par the schedule rate.
2. Out side tender should submit a payment certificate for working in a single piece of work for a valuation of 70% of tendered amount for any Govt. or semi Govt. deptt. During submitting the application for tender paper.
3. Xerox copy of valid income tax, Trade Licence, Vat & professional tax clearance certificate will be endorsed with the tender paper.
4. The rates should be considered as inclusion of all taxes.
5. Before submitting tender, tenderers are to satisfy himself by actual visit to site as regards the local condition & also other matter allied to said work any tender, submitting tender deemed to are done so.
6. Each tender must be accompanied by a deposit of earnest money (2%) prescribed in the notice in Bank draft or NSC duly transferred in favour of the District Magistrate & District Programme Coordinator, MGNREGA, Nadia.
7. Tenders should apply for tender from to DNO, MGNREGA in their own letter head along with the Xerox copy of the documents as mention in Sl.3 of conditions as well cost of tender paper (mention above) in the form of bank draft of any nationalized bank to be drawn in favors as mention Sl.6.
8. Tender who do not fulfill the above condition or are incomplete in respect will be liable to rejection.
9. If any tender withdrawals his tender before it is acceptance of refused within reasonable time withdrawals he shall be disqualified to after tender for a period which may extend upto one year.
10. The acceptance of lowest rate is not obligatory and the undersigned reserves the rights accept or reject any or all the tender without showing any reason.

11. In cases of unsuccessful tenders the earnest money will be refunded after issuing of work order on demand of such agency.
12. Shrinkage of the materials would be deducted from the stack measurement at site. Any sub standard material supplied at site would have to be replaced within 3 days from the date of receipt of such intimation at his own cost.
13. Supplied materials would have to stack as per instruction of Site Incharge.
14. Contractor/Supplier's will fully responsible of the supplied materials and installation at site till completion of the work.
15. Payment will be made when satisfy the work by in charge and fund is available.
16. Security deposit of 10% would be deducted from progressive bills and would be refunded only after expiry of the defect liability period (For the above works 6 months from the date of completion of work) and satisfactory condition of the work. No application praying for refunding Security Money will be entertained before the before the security period is over.
17. Contractors, when execute the works should strictly maintain the environmental & social management framework.
18. No tender will be received by post.


