(iii) Demand draft of unsuccessful bidders will be returned within fortnight or so. (iv) Every participant should submit 6(Six) samples of Musur Dal in sealed cover along with the bid (v) Successful bidder will deliver the food grains within Five (5) working days from the date of acceptance. If the supply is not done on schedule the bid may be cancelled even after the acceptance of bid. (vi) The Musur Dal should be packed in gunny bags with 50 Kg. in each bag exclusive of the weight of the said bag (vii) The undersigned reserves the discretion to accept or reject any tender in part or full without assigning any reason and may distribute the work among the participant without assigning any reason. In case of any dispute decisions of the undersigned will be final and will be binding upon all (viii) Tax will be deducted as per norms at source.
