**NOTIFICATION**

Notification is hereby issued in terms of Memo no. 303(21)-ES (CMDMP)/Estt-05/2013, dated- 19/5/2014 of the PD, CMDMP, School Education Department, Govt. of West Bengal read with decision taken place in the meeting of selection committee for engagement of DEO under CMDMP for Santipur Municipality held on 20/12/16 for engagement of Data Entry Operator (DEO) on contractual basis under Cooked Mid Day Meal Programme (CMDMP) for the under mentioned urban body in the following scale.

**Eligibility:-**

- Educational qualification:** - Graduation in any branch with certificate in computer application from the Govt. recognized institutions with minimum six (6) month's duration.
- Age:** - Maximum 40 years as on 1/1/2017 for General Candidates; relaxable by 3 years for the OBC/PH candidates and 5 years for the SC/ST candidates.

**Selection procedure:-**

- 1) Each willing candidate in this regard will have to apply to the SDO cum Chairperson of Municipality level selection committee for Santipur Municipality as per enclosed proforma. The application form either be downloaded from the following websites namely- [www.nadia.nic.in](http://www.nadia.nic.in); [www.santipurmunicipality.org](http://www.santipurmunicipality.org) or may be collected from Development Section of this office from any of the working day during the working hours up to 2:00 pm on 13/1/2017.

Following self attested photocopies of the documents are to be attached by the applicant along with his/her original application:-

- i) Admit Card of Madhyamik/Equivalent Exam for age proof
- ii) Mark sheets of all qualifications up to Graduate level
- iii) certificate in computer application from the Govt. recognized institutions with minimum six (6) month's duration
- iv) Experience Certificate in the computer related work ( at least duration of 1 year) in public/private field
- v) SC/ST/OBC-A/OBC-B/PH Certificate

Applications will be received in the Development Section of SDO Office, Ranaghat located at Ground Floor of new administrative building of SDO Office, Ranaghat on all working days from 10:30 am to 5:00 pm up to 13/1/2017 after making entry in receipt register against proper receipt. **No single application in post or through courier or through e-mail/fax or via any other electronic & social networking medium will be received & entertained.**

**Last Date of Application – 13/1/2017 up to 5:00 pm.**

If the total no. of applications is equal to and below 20, the candidates will be called for computer proficiency test directly.


If the total no. of applications are more than 20 nos. , short listing of candidates will be made on the basis of marks obtained in Madhyamik/Equivalent Exam (30% wightage), Higher Secondary /Equivalent Exam (40% weightage), Graduation (25% weightage), Experience of computer related work in any institution (private/public body) (at least duration of 1 year) (5% weightage).

The shortlisted candidates will then be called for computer proficiency test.

Final panel will then be prepared by the selection committee on the basis of marks obtained in computer proficiency test which include English typing( 15 marks), Bengali typing( 15 marks) , Excel with formula ( 20 marks) , Internet test( 10 marks) . The validity of the said panel will be next 1(one) year from the very date of publication of the said panel.

**Conditions:-**

- 1) The DEOs so engaged by the selection committee will be for a period of one year or less subject to renewal of contract on monthly or yearly basis by the Head of the Deptt./Office.
- 2) Financial implication for payment of professional fees to the DEO will proceed against the Budget provision of Management, Monitoring and Evaluation (MME) fund under Cooked Mid-day Meal programme.
- 3) Monthly professional fees shall be drawn as per format issued by the Finance Deptt., Govt. of WB memo no. 5859-F9Y), dated- 22/7/13 (copy enclosed).
- 4) Such engagement may also be terminated at the completion of the job or at the end of the project whichever is earlier.
- 5) The said engagement may also be terminated by the Head of the Deptt./Office on the basis of recommendation of the IT Deptt./NIC project leader or the project in-charge for unsatisfactory service , misconduct etc. of the incumbent concerned.
