The articles / equipments must be of best quality from reputed manufactures and preference will be given to those who has supplied similar items to INDIAN Navy, NDRF, Police, BSF, etc.

The tenders in sealed cover will be received from 08.02.2017 to 22.02.2017 from 11.00 am to 03.00 pm on all working days in the drop box kept at the chamber of Regional Transport Officer, Nadia, M.V Section, Administrative Building ground floor and will be open at 04.00 pm on 22.02.2017 at the chamber of Addl. District Magistrate (G), Nadia in the first floor collectorate building Krishnagar, Nadia. No tender paper will be accepted through electronic media. Tender papers dispatched through post and received after due date and time will not be entertained in any manner.

The tenders / authorized representative may remain present during the opening of tenders.

- VII. Tenderer will declare in a Non-Judicial stamp paper of Rs. 10 (ten) that he has no liability or financial debt to any person or financial institution and that must be submitted along with the tender paper.
- VIII. Payment will not be made for the articles which do not confirm the quality of the sample supplied. Any change from the approved sample may be allowed only after prior approval of the district magistrate, Nadia and decision of the District Magistrate is final in the matter.
- IX. The quoted rate to be given in both figure in words and include the transportation cost up to Santipur & Nabadwip respectively.
- X. Selected suppliers will have to execute and agreement in Non- Judicial stamp paper of Rs. 10 (ten) as to smooth and timely completion of the assigned work.
- XI. Credentials in support of supply of same to the Indian Navy /BSF/ N.D.R etc must be submitted with the tender.
- XII. Payment will be made only after supplying the products as per accepted specification and quality.
- XIII. Selected tenderer will have to produce reserves the right to reject any or all tender without assigning reasons whatsoever and is not bound to accept the lowest rate stating reasons thereof.
