ANNEXURE-II

Guidelines for engagement of staff (Group-C & D) under FFDA,NADIA

1. Engagement (not re-employment) will be done purely on contractual basis keeping the managing committee of FFDA in confidence, within the sanctioned strength from the retired employee only.
2. Engagement shall not be granted beyond the age of 65 years, under any circumstances. Thus, the age of a retired employee should not exceed 64 years on the date of interview.

Group-D- RS.6, 600/-
