1. The sealed quotation thus received will be opened on 24/07/2017 at 12-30 p.m. at the chamber of the Economic Botanist-IX, ZARS, Krishnagar, Nadia in presence of the quotationers remaining present.
2. Quotationers without requisite EARNEST MONEY shall not be accepted on any ground.
3. The intending quotationers may visit the ZARS, Farm from 10.07.17 to 14.07.17 between 11 a.m. to 1 p.m. on approach to the Store Keeper of ZARS, Krishnagar, Nadia to inspect the salable standing trees.
4. The quoted rate of above standing trees does not includes failing or other any cost in any case. Only cost of standing trees are to be quoted both in words and figures. The felling and cutting cost will be borne by the successful quotationer.
5. The successful quotationers will have to deposit the full amount of auctioned standing trees within 7(seven) days to the Asstt. Director of Agriculture (Farm), ZARS (F), Krishnagar, Nadia before cutting and lifting the said items.
6. The security money will be forfeited if the successful quotationer fails to lift the standing trees within 7(seven)days as specified above.
