Supply of food items

- 1) The tender document should be submitted with the photocopy of valid Trade License, PAN Card, P. Tax challan for last 6 months, Food License, SGST Regd Certificate issued by competent authority & experience in the same type of job in Govt/PSU sector.
- 2) No general order supplier (Govt./Non-Govt./Co.op) will be allowed to participate.
- 3) The hoteliers/Owners/ Caterers intends to submit the tender for supply of food items will have to deposit Rs. 5,000/- (Rupees five thousand only) in shape of Demand Draft drawn in favour of Secretary, District Health & Family Welfare Samiti-Nadia purchased from any nationalized bank & payable at Krishnagar as Earnest Money.
- 4) The Earnest money will be refunded to unsuccessful bidder within due course of time & it will be kept hold for the successful bidders, which may be converted as the security deposit.
- 5) The hoteliers/Owners/ Caterers intends to submit the tender for supply of food items will have to deposit Rs. 10,000/- (Rupees ten thousand only) in shape of Demand Draft drawn in favour of Secretary, District Health & Family Welfare Samiti-Nadia purchased from any nationalized bank & payable at Krishnagar as Security Deposit.
- 6) The successful bidders have to enter an agreement with District Health & Family Welfare Samiti in Nonjudicial stamp paper of Rs. 50/- before taking up the work regarding smooth & timely completion of the assigned work.

The qualified bidders may undergo with a sample verification of food quality taste & packaging test before the committee comprising of ACMOH (Sadar, Tehatta, Ranaghat, Kalyani) and Food Safety Officer.
