OFFICE ORDER

OFFICE ORDER NO. 239 / CONSERVATION CHARGE

DT. 13/09/2017

With reference to Principal Chief Conservator of Forests, Wildlife & Chief Wildlife Warden, West Bengal Order No. 04-WL/2017, dated 24/08/2017 and Chief Conservator of Forests, South-East Circle, West Bengal No. 1811 (2)/SEC/2M/08, dt. 11/09/2017. Conservation charge for the following items will be applicable for Bethuadahari Wildlife Sanctuary.

- 1) Entry Charge for Sanctuary – ₹ 50.00/Adult.
- 2) Photography as Tourist (Still, Video, Movie) – Nil.
- 3) Photography Commercial Shooting charge (Still, Video, Movie) – ₹ 5000.00/Day.
- 4) Location charges (for an unit of 10 person per location, for 3 days or parts thereof) – ₹ 20000.00
- 5) Location charges (for an unit of more than 10 person per location, for 3 days or parts thereof) – ₹ 50000.00
- 6) Location charges Government Sponsored (All types, including Location charge) – ₹ 5000.00

Note :-

- (1) For students on tours organized by their institution or certified by them to be a bonafide group, Entry Fee will be charged at 10% of above rates.
- (2) Commercial filming means the film, electronic, Magnetic, digital or other recording of a moving image by a person, business or other entry for a market audience with the intent of generating income, examples included, but are not limited to, feature film, videography, television broadcast or documentary, or other similar projects. Commercial filming activities may include the advertisement of a product or service, or the use of actors, model, sets, or props, (commercial still photography) means use of a model, set or prop, or shooting in a place not generally accessible to the public.
- (3) Children below 5 years are exempt from all fees.

This Order will come into force from 16/09/2017 and will be operative until further Order.
