Point 1:

On eligibility criteria on point 3.1 a) or b) under point 3. Eligible and qualified bidders under Section VI: General Conditions of Contract of terms & conditions of e-tender for supply of cooked diet:


Clarification should be read with the note "One bidder can apply for more than one hospital subject to his credential being calculated on the sum total of turnover of all hospitals where the bidder has submitted his bid" & point A. & B. Under point 3.1 under point 3. Eligible and qualified bidders under section VI: General Conditions of Contract of terms & conditions of e-tender for supply of cooked diet. The tender selection committee stressed on completed work here. The date of issue of terms & conditions issued by the Department of Health & Family Welfare, Govt. of West Bengal vide No.18(2)-MS/HF/O/MS/W-06/2017, dt.-15/01/18 i.e. 15/01/18 will be taken as the cutoff date.

Point 2:
