ELIGIBILITY CRITERIA

The bidder must be :

1. A registered organization with a valid trade license.
2. Experience of handling and /or providing similar services or products over the last three Years and those having experience of providing services and /or product in Nadia would be preferred.
3. No previous background of having defaulted with any work undertaken for the Government or Related organization. A declaration on an affidavit from the Authorized Representative would be mandatory.
4. No previous background of having any litigation or arbitration against Govt. or related organization. The bidder would have to submit a declaration towards the same.

TERMS & CONDITIONS

1. The bidder must provide on site warranty for the period as provided by OEM vendor / manufacturer from date of installation with parts for all CCTV equipment (DVR,HDD,Camera, Power Supply)
2. Agency have to attend the call within 3 days, else a penalty of Rs 500/-per day per unit will be imposed and deducted.
3. Supply of equipment shall be completed within 7 days after issuance of work order.
4. Warranty period will start from date of installation.
5. No additional charge will be given like transportation charges / TA/DA etc.
6. Rate should inclusive of all Taxes like service Tax/VAT/Sale Tax etc.
7. Tender shall be deposited to the District Magistrate, Nadia, P.O.- Krishnagar.
8. Earnest money deposits of Rs 5,000(Five thousand) will be given by SBI demand draft payable at SBI, Krishnagar Branch in favor of District Magistrate, Nadia. No tender will be accepted without earnest money.
9. The agency /Company should have valid up to dated P Tax, Trade License, I Tax, and VAT Registration with updated Tax payment Receipt.
