Name of the Work: Construction of temporary Stage, Stalls & other subsidiary structures at Tehatta High School Ground, Tehatta for the upcoming "Nadia District Sabala Mela, 2018". The details of the Works are given in Annexure-A.

Estimated Cost: 200000.00 (Rupees Two lakh only) Restricted amount up to Rs. 2,00,000.00 (As 1st Installment).

Period for dropping of Tender paper : Till 2:00P.M. on 25.09.2018 in the box.

Date of Opening : At 2:30P.M. onward on 25.09.2018 (liable to change)

1. All bidders must submit self certified photocopy of PAN, GST Number, Credential certificate (as per rules).
2. Time is the essence of contract. The successful contractors must complete the work by 12:00 Noon, 04.10.2018. No extension of time will be allowed except in special case. If the contractor fails to complete the work within the stipulated time the work order issued in his favour will be cancelled without assigning any reason therefore and failure to comply within time frame may lead to penalty as per W.B. Form 2911 of PWD and relevant rules.
3. All works will have to be done according to specification and drawing approved by authority and as per direction of the Sub-Divisional Officer, Tehatta. Any deviation will be penalized. No additional / modified work should be done without permission – however undersigned reserves right to modify scheme in public interest and tenderer shall cooperate and due payment for same, as decided by this Office, shall be paid to contractor.
4. No. consumable / Non- consumable materials will be supplied to the agency for any work from the office of the undersigned. Agency will be responsible for procuring all materials required for proper execution of work at his own cost. This office will not stand Guarantee to any deal of contractor.
5. Any rate above par of the schedule rate of work will not be ordinarily entertained as fund above estimated rate / value put to tender by this office does not exist.
6. The successful tender will have to start the work within three days from the date of issue of work order after execution of formal agreement as per rule and will have to complete the work within the time allowed for completion. Work order has to be collected within seven days of opening of tender otherwise offer may lapse and other contractor may given offer. No separate notice will be issued to successful tenderer, who will have to liaison with this office and collect work order by hand.
7. Acceptance of the lowest tender is not obligatory & the tender committee reserves the right to accept or reject any or all the tenders in part / full without assigning any reason what so ever and also to split up the tender work to more than one contractor in the interest of scheme execution and also tender committee reserves right to enter into negotiation in public interest with any / all tenderers or outsiders, such negotiation will be generally held in first phase , at office of undersigned at Noon on next working day after opening of tender. A notice in this regard will be displayed in office notice board and no other intimation will be sent, Hence close liaison with office advised
