===On the basis of written complaint submitted by one Chapa Dalui (Mondal) W/o Lt Balaram Dalui of Kalyani, Majerchar, Dakshinpara, PS Kalyani, Nadia, to the effect that on 05.08.18 at about 21.00 hrs one Astom Roy S/o Chottu Roy and two others of same locality kidnapped her minor daughter namely Puja Dalui Age-15+ yrs, for ill motive. On the basis of written complaint the above noted case has been started and being endorsed by I/C Kalyani PS, LSI Tithi Biswas took up investigation of this case

During investigation, previous I.O done all possible action in this case to recover the victim girl Puja Dului Age-15 + yrs, and arrested one FIR named accused person and got P.C for 3 days and conducted raid with P.C accused but no fruitful result has come. It appears that on further consideration of the allegations and the investigation done so far, prayer of previous I.O before Ld. Court for adding section 365/120B with the original proper section of law is allowed.

As per re- endorsed by I/C Kalyani PS I took up investigation of this case. During investigation I meet with the complainant to collect any information of victim girl, as well as I searched and held raid to recover victim girl and to arrest the rest FIR named accused persons but no fruitful result has come.

Hence, I pray before your kind self for the publication of the photograph of the Victim girl namely **Puja Dalui Age-15+ yrs of Kalyani, Majerchar, Dakshinpara, PS Kalyani, Nadia** along with his description in CIG.
