On opening of technical bid it appears that the following bidders have participated in following hospitals as noted against each

Through technical evaluation, for the undernoted bidders, the tender selection committee has found the following lacunas as noted against each

Samir Kr. Ghosh	Non-submission of bank solvency certificate, Non-submission of notarized credentials,
Ganesh Ch. Ghosh	As per his submitted Bank solvency certificate, he is not solvent for District Hospital, Nadia, As per his submitted credentials/documentary evidence, the bidder does not have sufficient work value for District Hospital, Nadia, Ranaghat SDH, Tehatta SDH, Santipur SGH, Nabadwip SGH
Standard Business Syndicate	Submitted Bidders' undertaking not as per required format mentioned in point 13. Under Section VII: General Instruction to Bidders of terms and conditions of tender
United Order And Supply Co-operative Society Ltd.	Submission of non-notarized Proformawise performance statement, Submission of non-notarized Credentials/documentary evidence, Non-submission of Self-declaration

Abdur Rouf, Proprietor: Minicon	As per his submitted credentials/documentary evidence, the bidder does not have sufficient work value for Ranaghat SDH, Tehatta SDH, Chakdaha SGH, Santipur SGH, Nabadwip SGH
Asit Kumar Daw	As per his submitted credentials/documentary evidence, the bidder does not have sufficient work value for Ranaghat SDH

It appears that Shiba Prosad Banerjee is technically eligible for all the Hospital he has submitted bids i.e. District Hospital, Nadia, Ranaghat SDH, Tehatta SDH, Santipur SGH, Nabadwip SGH.

It also appears that Lucky Catering Service is technically eligible is technically eligible for Chakdaha SGH (the only hospital he has applied for) and The Jana Enterprise is technically eligible for Nabadwip SGH (the only hospital he has applied for).


So, it appears that for District Hospital, Ranaghat SDH, Tehatta SDH, Chakdaha SGH, Santipur SGH, Nabadwip SGH, there are only 1(one), 1(one), 1(one), 1(one), 1(one), 2(two) technically eligible bidders respectively.

So, it appears that the tender selection committee has not found minimum 3(three) number of technically valid bidders (required as per G.O. No.5400-F(Y), dt.-25/06/12 of Finance Department, Audit Branch, Govt. of West Bengal) for any of these 6 (six) hospitals.

So, the tender selection committee declares that this diet tender for District Hospital, Ranaghat SDH, Tehatta SDH, Chakdaha SGH, Santipur SGH, Nabadwip SGH is cancelled.

It also appears that only (1) online bid has been submitted in case of diet tender for Dr. B.C.Roy Chest Sanatorium. So, due to lack of sufficient number of bidders (as per G.O. No.5400-F(Y), dt.-25/06/12 of Finance Department, Audit Branch, Govt. of West Bengal), the tender selection committee decides not to open that only 1(one) bid and also declares that this diet tender for Dr. B.C.Roy Chest Sanatorium is cancelled.

It also appears that no bid has been submitted in case of diet tender for Netaji Subhash Santorium. So, the tender the tender selection committee declares that this diet tender for Netaji Subhash Santorium is cancelled.




