
On opening of technical bid, it appears that 5 (five) bidders namely 1) Aisha Enterprise, 2) Bhattacharjee Enterprise, 3) Br Biochem Life Sciences Pvt. Ltd., 4) Indo Scientific and Surgicals Pvt. Ltd, 5) Ms Matrix Eco Solution Pvt. Ltd.

Out of these 5(five) bidders, 2 (two) bidders are found to be technically valid. Their names are Aisha Enterprise & Indo Scientific and Surgicals Pvt. Ltd.

On the otherhand, Bhattacharjee Enterprise, Br Biochem Life Services Pvt. Ltd., M/s Matrix Eco Solution Pvt. Ltd. Are found to be technically invalid due to folling reasons:

- 1) Bhattacharjee Enterprise: Non-submission of audited profit & loss A/c for Fy 16-17
- 2) Br Biochem Life Services Pvt. Ltd.: Non-submission of P.Tax registration valid for FY 18-19, Non-submission of Trade License valid for Fy 18-19
- 3) Ms Matrix Eco Solution Pvt. Ltd.: Non-submission of P.Tax registration valid for FY 18-19, Non-submission of Trade License valid for Fy 18-19.


So, due to unavailability of sufficient number of valid bidders as per norms laid down vide G.O. No.-5400-F(Y), dt.-25/06/12 of Finance Department, Audit Branch, Govt. of WB; the tender selection committee unanimously decides to declare this e-tender as cancelled.
