The quotation has to be submitted with mentioning the total repairing charges & total amount along with other charges if any. Quotationers must submit the quotation in a sealed envelope superscripted with 'Quotation for Repair works of Govt. Ambulance No.WB-51-6585' along with the photocopy of valid GST No., Trade License in the name of the Firm, Certificate of Authorisation by competent authority for repairing of Govt. Vehicle, Income Tax Clearance Certificate for the last F.Y. and may submit any other certification as job experience for servicing on Govt. Vehicle.

The genuine spare parts to be purchased from authorized dealer and the cost of genuine spare parts inclusive all taxes and the cost of labour charges for the undermentioned repair works may be mentioned separately in the quotation.

The quotation should reach on or before 29th Jan'2019 by 1.00 p.m. positively to the undersigned. The Quotation will be open after 3.00 p.m. on 29.01.2019 in presence of the Quotationers if they are eager to be present.

The works of Govt. Ambulance No.WB-51-6585 (Model - TATA Sumo) are as below :-

1. Both side rear mudguard inner-side corrode portion necessary repairing by sheet metal welding.
2. Back side floor damaged portion necessary repairing by sheet metal welding.
3. Front driver seat and second seat damaged floor portion replaced by sheet metal welding job.
4. All door inner & outer damaged panel replacement with necessary repairing job by sheet metal welding job.
5. Replacement of damaged body mounting with damage bolts after removing the body from chassis.
6. Wind shield glass frame corroded portion necessary repairing job with replacement of damaged wind shield glass rubber.
7. Electrical wearing damaged portion necessary repairing with replacement of damaged hooter, headlights, horn upper & lower, cut-out & relay.
8. Replacement of all damaged bumper corners and all doors & windows bits, garnish & felts.
9. Entire vehicle painting job (double coat) after applying primer paint.
10. Chassis and under-carriage necessary painting job after removing the body from chassis.
