Re-Tender Notice No.-04/2018-2019(Re-tender)

Sealed tenders are hereby invited for the fruits of Mango (trees of different ages & variety) orchards except the places between Shade net House & Guava Stooling plot at State Horticultural Research & Development Station, Krishnagar, Nadia **for the current fruiting season up to July, 2019**. Interested tenderer can offer price observing the following terms & conditions strictly.

Terms & Conditions:

- (1) Super scribe the sealed envelope containing tender as **“Re-Tender for fruits of mango orchards for the current fruiting season”** addressed to the Deputy Director of Horticulture Nadia, Krishnagar, Nadia with an **Open Demand Draft of Rs. 35,000/- (Rupees Thirty five thousand) only as earnest money in favour of Deputy Director of Horticulture Nadia, State Horticulture Research & Development Station, Krishnagar in any Nationalized Bank payable at Krishnagar**. Tender without the requisite earnest money will stand invalid and summarily be cancelled.
- (2) Rate should be quoted both in figure and words in prescribed tender paper which will be available in the office of the Deputy Director of Horticulture Nadia, State Horticultural Research & Development Station, Krishnagar, Nadia during office hours and also in the Website (www.nadia.nic.in).
- (3) The Tenderer may observe the conditions of the orchards after taking permission from the Deputy Director of Horticulture Nadia, State Horticultural Research & Development Station, Krishnagar, Nadia / Uttam Biswas (U.P.P.S) during office hours.
- (4) Tender can be submitted duly at the tender box kept at office of the Deputy Director of Horticulture Nadia, State Horticultural Research & Development Station, Krishnagar, Nadia from 11.00 am to 3.00 pm at working days and also by Postal system within the scheduled period.
- (5) **The last date of receiving tender is 28.02.2019 up to 1.00 pm** at the office of the Deputy Director of Horticulture Nadia, State Horticultural Research & Development Station, Krishnagar, Nadia.
The tender will be duly opened on the same day (28.02.2019) at 2.00 pm.
The last date of accepting tender and date of opening may be shifted to the next working day in unavoidable circumstances.
- (6) **The rate should be quoted above Rs.3, 40,000/- (Rupees Three Lakhs Forty Thousand) only** for the said tender of orchards **for the current fruiting season up to July, 2019**. Tender quoting rate below **Rs. 3, 40,000/- (Rupees Three Lakhs Forty Thousand) only** will not be treated as valid.
- (7) The earnest money of the successful tenderer will only be treated as Security Deposit and the same will be returned back after satisfactory completion of the tender period. The Security Deposit will be forfeited if any damage to Govt. property is caused due to the successful tenderer during the tender period.
- (8) **The successful tenderer must deposit full amount of his /her offered amount within the seven working days from the date of opening the tender within 1.00 pm. Otherwise the next higher tenderer will be the successful tenderer.**
- (9) The successful tenderer can collect the fruits of mango orchard (specified by office) up to 31.07.2019.
- (10) The successful tenderer has to make his / her own security arrangement during the tendered period.

- (11) Branches of any fruit tree of the tendered Mango orchard can be utilised as scion or any other propagation works for the interest of the Govt. farm during the tender period. Pruning and training of trees will also be done if required for the maintenance of the orchard during the tender period.
- (12) In case, the successful tenderer does not finally agree to pay the tendered amount within the period mentioned above the security deposit of that tenderer will be forfeited.
- (13) Authority will bear no responsibility for any damage of fruits /trees due to any natural calamity /other means.
- (14) Authority can impose any condition if required at any stage of the tender.
- (15) The successful tenderer must inform the name and address of the persons engaged for security (maximum 10 persons) as well as for collection of fruits during the valid period to the office of the Deputy Director of Horticulture Nadia , State Horticultural Research & Development Station , Krishnagar , Nadia . Other Persons will not be allowed within the farm. The security persons engaged by the Successful tenderer will have to abide by the rules & regulations of the office.
- (16) The successful tenderer must communicate time to time with the Deputy Director of Horticulture Nadia /respective U.P.P.S., State Horticultural Research & Development Station , Krishnagar , Nadia .
- (17) The movement of the vehicle engaged for transporting the collected fruits within the farm will be allowed during 6.00 am to 6.00 pm. with giving information to the Security guard of the Farm.
- (18) The authority reserves the right to accept /reject the tender without mentioning any reason thereof at any stage deemed fit by it.
