Minutes of pre-bid meeting on 05/03/2019 regarding e-tender for procurement of spectacles with power glass & black goggles vide this office Memo No.-CMOH-Nad/PH/NPCB/1944, dt.-26/02/2019:

1) One present probable bidder sought clarification regarding specification about the lense to be provided i.e. whether it would be glass or fibre.

The tender selection committee along with the present probable bidders unanimously came to the conclusion that in public interest the better item i.e. glass which will be more durable due to scratch free nature will only be accepted. Fibre will not be accepted. This is done as per technical advice of the eye specialist present.

2) Protective casing (hard) is to be provided and the rate is to be quoted inclusive of everything. The casing is to be embossed with the following:

Cleaning cloth should be inside the case. However, these items are not required for black goggles.

3) As per norm, **FITTING CERTIFICATE** along with CRC (Consignee receipt Certificate) is a must from facility incharge i.e. from the Superintendent/ B.M.O.H concerned as a pre-requisite for clearing the bill.

4) This is again being reiterated that the technical bid evaluation will be having two parts i.e. 1st part is document verification & 2nd is quality testing by our experts. Only after clearing these two steps, the bidder will be eligible for financial bid.


5) The penalty will be assessed as per norms on the basis of pending supply value only.

6) The 'Tender Value' as shown in work item details of tender ID 2019\_HFW\_220563\_1 of www.wbtenders.gov.in regarding e-tender for procurement of spectacles with power glass for post-operative cataract patients is to be read as Rs. 15,84,248/-(fifteen lakh eighty four thousand two hundred and forty eight) in place of Rs. 1,21,93,720/-(one crore twenty one lakh ninety three thousand seven hundred and twenty).
