

Justice Debangsu Basak, Calcutta High Court** in WP No. 2765(W) of 2019 along with WP No. 2761(W) of 2019, WP No. 24746(W) of 2018, WP No. 24863(W) of 2018, Can 9764 of 2018, Can 9765 of 2018, Can 9766 of 2018, Can 9767 of 2018 gave ruling "The State is at liberty to undertake a fresh tender process as noted in its writing dated February 28, 2019. Such a tender process will not prejudice any of the parties in the writ petition. Learned Advocate appearing for the petitioners submits that, no further interference is called for. In such circumstances, W.P No. 24746 (W) of 2018, WP 24863(W) of 2018, WP 2765(W) of 2019 and WP 2761(W) of 2019 are disposed of. CAN 9764 of 2018, CAN 9765 of 2018, CAN 9766 of 2018 and CAN 9767 of 2018 are disposed of accordingly." With this background, we received the Memo No. HHM/1H-141-2018/99, dt.13/03/2019 of the Director of Health Services, Government of West Bengal and on the basis of which the Re e-tender (2nd call vide this office Memo No. CMOH-Nad/9101, dt. 05/10/2018) for cooked diet supply to patients of the hospitals of Nadia is hereby declared as cancelled and the present supplier may continue at Chakdaha SGH and Dr. B. C. Roy Chest Sanatorium at revised rate till award of next contract.
