5. Bidders shall quote rates both in figures and words. If there is any difference between the rates in figures & in words, the higher of the two, shall be considered.
6. The tenders submitted should be valid for a period of 90 days from the date of opening of bids.
7. The condemned articles will be disposed of on "AS IS WHERE IS BASIS", "AS IS WHAT IS BASIS" and no guarantee for its worthiness or quality will be given by this department.
