Terms and Conditions



2. The specimen card may be seen from the office during working hours.
3. Re-quotation should be accompanied with self attested photocopy of the valid Trade License, PAN Card, Voter Card or Aadhar Card and GST Certificate (if applicable). Rate should be quoted (excluding GST) per 1000 pieces in own letter head in figure and words also.
4. Re-quotation should be accompanied with original **Demand Draft of Rs.2,000.00 (Two Thousand)** only drawn in favour of **"W. B.
