
Financial bid evaluation summary in connection with re-tender(3<sup>rd</sup> call) for construction of common collection site at Bethuadahari RH vide CMOH Office, Nadia Memo No.-CMOH-Nad/2185, dt.-09/03/2018:

On opening of financial bid, it appeared that M/s Maa Enterprise had quoted Rs.526485.77(five lakh twenty six thousand four hundred and eighty five point seven seven) which is 15.15 (fifteen point one five) % below than estimated rate shown in online BOQ in this re-tender vide Memo No.-CMOH-Nad/2185, dt.-09/03/2018).

So, as per G.O.No.-925-F(Y), dt.-14/02/17 read with G.O. No.-4378-F(Y), dt.-, dt.-13/07/17 of Finance Department, Audit Branch, Govt. of West Bengal, prayer for acceptance of rate quoted by only technically qualified bidder was sent to State vide this office Memo No.-CMOH-Nad/6480, dt.-18/07/18, Memo No.-CMOH-Nad/7018, dt.-02/08/18. Clarification was given vide Memo No.-CMOH-Nad/9257, dt.-11/10/18. Required documents was submitted vide this office Memo No.-CMOH-Nad/10321, dt.-05/12/2018.

Vide this office Memo No.-CMOH-Nad/1211, dt.-29/01/2019, prayer for acceptance of rate quoted by only technically qualified bidder was sent to State in annexure published vide G.O. No.-6989-F(Y), dt.-19/11/18 of Finance Department, Audit Branch, Govt. of West Bengal. Later, this matter has again been intimated vide this office Memo No.-CMOH-Nad/2875, dt.-26/03/2019.

Now, as this office is in receipt of Memo No.-WB/State FMG/Singly-108/979, dt.-11/06/2019 of the Programme Officer, NHM & Dy. Secretary to the Government of West Bengal which intimates us in the 15<sup>th</sup> Departmental Tender Committee meeting, recommendation had been done for acceptance of L1 rate of Rs. 526485.77(five lakh twenty six thousand four hundred and eighty five point seven seven) only of Maa Enterprise; the tender selection committee unanimously decides to accept M/s Maa Enterprise as the successful bidder with his rate quoted i.e. Rs. 526485.77(five lakh twenty six thousand four hundred and eighty five point seven seven).
