During technical bid evaluation, the tender selection committee has generously dealt the matter of submission of schedule of bank accounts, submission of P.Tax (Valid for FY 2018-19/2017-18), submission of credential of work by the bidders, so that maximum number of participation may be ensured at financial bid for the interest of public service.


However, as for e-tender for repair & renovation work for HWC at Karuighachi PHC, Donkhira PHC, Kastodanga PHC, Madanpur II (Alaipur) PHC, only 2 (two), 1(one), 1(one), 1(one) bids were submitted, so due to unavailability of sufficient number of bidders as per Government norms, the tender selection committee unanimously decides to declare for e-tender for repair & renovation work for HWC at Karuighachi PHC, Donkhira PHC, Kastodanga PHC, Madanpur II (Alaipur) PHC as cancelled.
