Financial bid evaluation summary regarding e-tender for repair & renovation work for HWC at sub-centres ref: Memo NO.-CMOH-Nad/4903, dt.-18/06/2019:

On opening of financial bid of technically accepted bidders for Poragachha (Kulgachhi) Sub-centre at Krishnagar-I Block, it appears that Siddhartha Ghosh had quoted the L1 rate. He had quoted 19.25% (nineteen point two five percent) less than the estimated rate shown at BOQ. So, the tender selection committee unanimously accepted Siddhartha Ghosh with his quoted rate Rs. 519935.62 (five lakh nineteen thousand nine hundred and thirty five rupees and sixty two paisa).

On opening of financial bid of technically accepted bidders for Boro Chandghar Sub-centre at Kaliganj Block, it appears that Manas Sarkar & Co. had quoted the L1 rate. This agency had quoted 24.88%(twenty four point eight eight percent) less than the estimated rate shown at BOQ. So, the tender selection committee unanimously accepted Manas Sarkar & Co. with their quoted rate Rs. 471431.98 (four lakh seventy one thousand four hundred and thirty one rupees and ninety eight paisa).


On opening of financial bid of technically accepted bidders for Bilkumari Sub-centre at Nakashipara Block, it appears that Manas Sarkar & Co. had quoted the L1 rate. This agency had quoted 22.97% (twenty two point nine seven percent) less than the estimated rate shown at BOQ. So, the tender selection committee unanimously accepted Manas Sarkar & Co. with their quoted rate Rs.495322.27(four lakh ninety five thousand three hundred and twenty two rupees and twenty seven paisa).


