Financial bid evaluation summary regarding re-etender for security service at District Hospital, Nadia for this office Memo No.-CMOH-Nad/3202, dt.-30/03/2018:

On opening of financial bid for District Hospital, Nadia, it appears that M/s Indian Traders had quoted 0% management fee.

So, as per resolution taken by the tender selection committee, as per norms laid down vide G.O. No.-925-F(Y), dt.-14/02/2017 of Finance Department, Govt. Of W.B., permission for acceptance of bid submitted by M/s Indian Traders for District Hospital, Nadia was sought from the Joint Secretary, M.S. Branch, WB vide Memo No.-CMOH-Nad/6969, dt.-01/08/2018 (information was sent in annexure vide G.O. No.-4378-F(Y), dt.-13/07/2017 of Finance Department, Govt. of West Bengal), Memo No.-CMOH-Nad/9207, dt.-10/10/2018,

Later, in response to clarification sought by the Joint Secretary, M.S. Branch, WB vide No.-67-MS/HF/O/MS/S-05/2018, dt.-14/01/2019, letter vide Memo No.-CMOH-Nad/965, dt.-18/01/2019 was sent to him.

Later, permission was sought from the Joint Secretary, M.S. Branch, WB vide Memo No.-CMOH-Nad/1210, dt.-29/01/2019 with information furnished in annexure vide G.O. No.-6589-F(Y), dt.-19/11/18 of Finance Department, Govt. of West Bengal. In this connection, letter vide Memo No.-CMOH-Nad/1673, dt.-14/02/2019, Memo No.-CMOH-Nad/2876, dt.-26/03/2019 was also sent to the Joint Secretary, M.S. Branch, WB.

Later, in connection with Memo No.-HF/O/MS/S-05/2018/347, dt.-18/07/2019 of the Jt. Director of Health Services (HA Branch), WB, clarification was sought from the Proprietor, M/s Indian Traders vide Memo No.-CMOH-Nad/5877, dt.-22/07/2019.

In response, the vendor has submitted his letter to CMOH Office, Nadia on 24/07/2019 which was sent to the Joint Secretary, M.S. Branch, WB 29/07/2019 via email along with remarks from the then Acting CMOH, Nadia.

Now, this office has received minutes of 18th meeting of Departmental Tender Committee held on 02/08/2019 at Swasthya Bhawan. Via email from State Financial Management Group, National Health Mission, Department of Health & Family Welfare, Govt. of West Bengal on 21/08/2019. It shows that the departmental tender committee has recommended for acceptance of rate.

So, the M/s Indian Traders is being accepted with 0%(zero percent) management fee for District Hospital, Nadia.


