**Notice Inviting Tender No:-02/2019-20**

Sealed tenders are hereby invited for sale of mango fruits of the mango orchard of the State Horticultural Research & Development Station, Krishnagar, Nadia for the year 2020. The rate in plain papers duly signed by the tenderer may be dropped in the tender box of District Horticulture Office following the terms and conditions mentioned below.. Interested tenderer may visit the orchard before dropping the tender paper. The last date of submission of the tender is 15.01.2020 up to 2 P.M and the tenders will be opened on the same day at 3 P.M at the State Horticultural Research and Development Station, Krishnagar, Nadia.

**Terms & Conditions:-**

1. Rate to be offered above the base price.
2. Minimum Base Price of mango fruits is Rs.2,50,000/-(Rupees Two Lakh Fifty Thousand ) only.
3. The successful tenderer will have to deposit in cash the full amount of price rate mentioned in his/her tender paper at the time of receiving the fruit collection order from the office.
4. The successful tenderer will have to collect fruits from the orchard at his own cost without any damage to the orchards or other Govt. Properties.
5. The Successful tenderer will have to arrange security of tendered orchard at his own cost upto the last date of Fruit Collection.
6. If the successful tenderer expresses his unwillingness to receive collection order of fruit within three working days after deposition of sale price then he will never be allowed to take part in any sort of auction/ tender of DHO/SHRDS, Krishnagar, Nadia and the decision to sale the fruits to the second highest tenderer will be taken by the undersigned without assigning any reason thereof.
7. The successful tenderer has to deposit a demand draft of Rs.10,000/-(Rupees ten thousand only) drawn in favour of Deputy Director of Horticulture, Nadia from any Nationalised Bank of Krishnagar Branch as security money which is refundable. But if the orchard or any govt. property of SHRDS or DHO, Nadia is damaged by the tenderer or the persons engaged by him then the security money will be forfeited.
8. The branches of the mango trees may be used by the DHO or SHRDS for propagation of planting materials.
