4. Specification wise sample should be produced before the selection committee on **21/05/2013 up to 2:00 PM** positively. In case of successful tenderers, the Sample will be refunded after two months from the date of last supply and in case of unsuccessful tenderers it will be refunded on the same date.
5. Attested copies of Pan Card, Income Tax & Sale Tax clearance certificate including VAT Registration Certificate, trade license, and credential certificate from concerned Authority for supply the same are to be submitted along with the application.
6. The tender should invariably and clearly be mentioned in the letter head pad duly signed by the tenderer. The rate must be quoted in figure and words neatly and correctly in English including loading/unloading, transportation and all other charges.
