Terms & conditions :-

- ix) Rate should be quoted per 100 (hundred) of kites including all charges viz. carrying, lifting, loading etc. on the body of Quotation paper.
- x) **All Kites should be superscribed with Glossy colouring, relatively bigger size and shape i.e. 2' -11" X 1'-10" in measurement so that messages of SRER and the logo of ECI are prominently displayed and are able to generate interest, curiosity and awareness among the electors. Sample Paper of kite should be submitted with quotation papers, otherwise the quotation paper will be rejected.**
- xi) Earnest money to the tune of Rs.5,000/- (Rupees five thousand) only is to be deposited through bank draft along with the the quotation papers in favour of District Magistrate, Nadia.
- xii) Copy of registration certificate, up-to-date VAT Return copy, Income Tax, Professional Tax Clearance Certificate, Credential and trade license should be submitted with the Quotation papers.
- xiii) The Quotation should be submitted at the specified box kept at the chamber of the Officer-in-Charge, District Election Section, Nadia up to 10th September, 2013 within 12-00 Noon in a sealed envelope super scribed as "**Quotation for supply of bigger size and shape kite**" for SVEEP programme.
- xiv) All quotation will be opened at the office chamber of Addl. District Magistrate (Elec.), Nadia at 12-30 p.m. of 10th September, 2013, where the Quotationers or duly authorized representatives may remain present.
- xv) The entire supply of kite has to be done to the District Election Section, Nadia by 14.09.2013.
