Sealed tender are invited from the bona fide, reputed and resourceful agencies / suppliers for supply of sports goods (Foot Ball, Volley Ball, Volley Ball Net, Cricket Set Duge and Normal, Carrom Board Set, Badminton Set and Discuss, Shot Put, Javelin, Skipping Rope etc.) will be made after the type of quality and the rates are examined by the District Level Purchasing Committee. Detail terms and conditions are furnished below.

1. The agencies / Suppliers should have credentials of at least 50% of the total tendered / quoted amount in support of their capacity for similar job during the last 3 years before purchase of Tender Form.
2. Samples of items will have to be deposited by the lowest and 2nd lowest tender. These samples will be returned to the suppliers concerned after the completion of the supply. The decision of the District Level Committee regarding the quality of the sports goods will be final. If the delivered supplies, are not found to be up to the mark with the quality of the approved samples, the entire supply order will be liable to be declared cancelled by the committee and the security deposit will be liable to be forfeited by the committee.
3. The successful tenderer will have to arrange, at his cost for supply of the sports goods to the different Blocks / Municipalities and District Youth Office under the jurisdiction of Nadia District.
