MEMORANDUM

Sub :- Providing Gratuitous Relief (G.R) in Cash to the families who have lost their houses, food reserve and any others means of support themselves and required immediate sustenance after a Calamity.

In case of natural calamities the families which lose their house, food reserve and do not have any other means of sustenance after the Calamity require considerable support from the Government for leading a normal life. The matter has been active consideration of the Government for the some time. After detail consideration, the Government has decided to provide Cash Relief for 30(Thirty) days to each family.

2. The part of the assistance would be provided from the State Disaster Response Fund (SDRF) and rest would be provided from State Budget.
3. The assistance would be provided to the families which
 - i) Have no food reserve or their food reserves have been wiped out in the calamity,
 - ii) They have no other immediate means of support.
 - iii) Identified beneficiaries are not housed in the Relief Camps.
 - iv) Identified beneficiaries are not receiving any assistance in Cash or Kind.
4. The Government would provide Rs.5000/- (Rupees Five Thousand) only per family for a period of 30(Thirty) days who have lost their houses and their entire food reserve have been wiped out in the calamity and they

have no other means of support. Out of this Rs.5000/-, Rs.4200/- would come from "2245-02-101-NP-001-50-V" and Rs.800/- would come from "2235-02-800-NP-004-50-V".

5. The District Authority would be responsible for identification of beneficiaries of this scheme. Requisite Fund would be placed with the District Authority for immediate disbursement.
6. This has the concurrence of the Finance Department vide U.O. No.1362 dt.24.10.13.


