

Minutes of the Meeting of District Level Vigilance & Monitoring Committee held on 01.12.2014 in the Conference Room (at 3rd floor) of District Administrative Building, Nadia.

The list of the participants annexed separately.

In the absence of the Chairperson, DLVMC, Nadia, the Sabhadhipati of Nadia Zilla Parishad took the chair.

The Agenda of the meeting was placed through Power Point Presentation by the concerned officers of the respective Departments.

The following points emerged after interaction with the members:

I) MGNREGS (Mahatma Gandhi National Rural Employment Guarantee Scheme):

- 1) Utilization of available fund of the scheme to be expedited. Two (02) No. of FIRs have been lodged regarding discrepancies in case of Dhoradaha-IGram Panchyat under Karimpur-II Panchayat Samiti.
- 2) Letter issued to the Block Development Officer, Nakashipara Development Block to lodge FIR in case of discrepancies in case of Birpur Gram Panchayat.
- 3) Out of the other 07(seven) pending cases, FIR or other 'necessary steps' may be taken for 3-4 cases.
- 4) MGNREGA-NBA-IAY convergence to be 100% in this district.
- 5) Ranaghat-I, Tehatta-II, Krishnagar-I, Nabadwip & Kaliganj are lagging behind in creating Man Days.

Action: AEO (NZZP), DNO (MGNREGS), Sabhapati, Ranaghat-I/Tehatta-II/Krishnagar-I/Nabadwip / Kaliganj & BDO Ranaghat-I, Tehatta-II, Krishnagar-I, Nabadwip & Kaliganj.

II) IAY (Indira Awas Yojana):

- 1) The problem in case of Nabadwip has been sorted out and 409 No. of new cases has been sanctioned.
- 2) Total available fund has almost been exhausted.

Action: AEO, NZP & Secretary, NZP

III) NSAP (National Social Assistance Programme):

- 1) Pension is being disbursed within 7th of every month.
- 2) Steps to be taken so that automatic conversion of beneficiaries from 79 (and above) years to 80 years.

- 3) Problems regarding Branch Post Offices Sub Post Offices to be specifically mentioned by the Executive Officers of the concerned Panchayat Samities.
- 4) Physical Verification of the eligible beneficiaries to be completed immediately so that these people can get pension from April,2014 onward.

Action: DP&RDO, Nadia

IV) Nirmal Bharat Abhiyan/Sabar Sauchagaar:

- 1) All the Sanitary Mart to be asked to submit total data regarding Individual House Hold Latrins(IHHL) constructed so that 100% achivement can be ensured.
- 2) Data entry for 95% of the IHHL constructed (or 1.5 lakh number of IHHL)for Swachha Bharat Mission to be completed within this year,i.e., by 31.12.2014.
- 3) Sabar Sauchagaar campaign to be intensified.
- 4) Name of the beneficiaries to be uploaded regularly.
- 5) Allotment would be made as per the figure (of beneficiaries) uploaded.

Action: AEO, NZP & Secretary, NZP

V) BCW (Backward Class Welfare) :

- 1) There is no BCW Inspector in Nabadwip & Tehatta-I ,so Caste Certificates in these Panchayat Samities/ Blocks could not be issued in time.
- 2) There are 7494 number of Caste Certificates are still pending .
- 3) Renewal of Pre-Matric Scholarship to be completed by January,2015.
- 4) Renewal of Post-Matric Scholarship also to be completed by January,2015.
- 5) Target for both 3&4 is 1.5 lakh
- 6) Achievement for *Sikshyashree* is **96000(ninety six thousand)** beneficiaries-highest in the state so far.
- 7) Target for *Sikshyashree* was **1,00,000(one lakh)**
- 8) Short fall in achieving target maximum in Krishnagar-I Block/Panchayat Samiti.
- 9) A new target of **1, 10,000 (one lakh ten thousand)** numbers of *Sikshyashree* beneficiaries to be achieved by 15.12.2015.
- 10) No Caste Certificate or Additional Income Certificate will be required for registration for
- 11) *Sikshyashree* ; only self-declaration by the parents will be sufficient.
- 12) Registration of individual for *Sikshyashree* to be done immediately even without Bank Account .However the same to be opened within 10 to 15 days without fail.
- 13) Sabhapaties are to monitor the *Sikshyashree* programme and report to the Sabhadhipati.

14) As per the direction of the Director, BCW, no individual loan for OBCs can be entertained; only Group loan can be processed.

VI) PMGSY (Prime Minister Gram Sarak Yojana):

- 1) Progress is little slow in PMGSY due to shortage of fund.
- 2) However, 100(hundred) kilometers of road to be completed under PMGSY by 31.12.2014.
- 3) A letter will be sent to the Department giving details of the target and procedure adopted so far there by asking for immediate release of fund in this regard.
- 4) RIDF (XX)(Rural Infrastructure Development Fund)-08 No. of works ,totaling 36 Kilometers;07 works to be completed within December,2014.

Action: Executive Engineer, WBSRDA, Nadia.

VII) RGGVY (Rajiv Gandhi Garmeen Vidhutikaran Yojana) :

- 1) 59031(fifty nine thousand thirty one) number of BPL families to be benefitted with completion of RGGVY-12th Plan or RGGVY-III.
- 2) 65000(sixty five thousand) number of APL families to be benefitted with completion of RGGVY-12th Plan or RGGVY-III.
- 3) Stipulated date of completion: 21.10.2016.

Action: Project Manager (RGGVY), WBSEDCL, Nadia.
