

MINUTES OF THE MEETING OF DLVMC HELD ON 18.02.2014 AT 3.00 PM. IN THE MEETING HALL OF
NADIA ZILLA PARISHAD

In absence of the Chairman, DLVMC, Nadia the Sabhadhipati of Nadia Zilla Parishad took the chair.

The agenda of the meeting was placed through Power Point Presentation by the concerned officers of the respective Departments.

The following points emerged after interaction with the members:

MGNREGS(Mahatma Gandhi National Rural Employment Guarantee Scheme):

- 1) The utilization of available fund of the scheme for the district has attained at 92.5 %
- 2) Necessary action has been taken up for participation of women in the scheme.
- 3) Schemes like re-excavation of water bodies (Khal, beel, ponds etc) have been taken up.

IAY (Indira Awas Yojana):

- 1) The utilization of fund for the 1st installment is about 70%.
- 2) Fund for the second installment would be released as soon as it is received.
- 3) Specific complaint for (i) score jumping (ii) allotting house under IAY having pucca house, is required for causing field verification and necessary action(Krishnagar-I : Dignagar / Deypara)
- 4) It was advised for displaying the list of beneficiaries in the Notice Board of the Gram Panchayat for "Claims – Objection" before disbursing the fund for 1st installment. This may help in reducing the wrong beneficiaries in future.

Action : AEO, NZP, Sabhapati, Kgr-I PS, BDO, Kgr-I Block.

NBA/TSC (NIRMAL BHARAT AVIJAN / TOTAL SANITATION CAMPAIGN):

- 1) The total number of toilets constructed so far is 1,01,500.
- 2) The construction of Anganwadi toilet is lagging behind due to low cost of estimate.
- 3) There is a target for establishment of Solid Liquid Waste Management Projects in all the Gram Panchayats of the district. At present, out of the proposed six projects only four projects have been done.
- 4) It was requested that Block Development Officer, Krishnagar-I Block and the Sabhapati, Krishnagar-I P.S. should sit and discuss together for liquidating all sorts of misunderstanding and patch up the communication gaps.
- 5) It is great pleasure to announce that Tehata-II Block secured first position in India in respect of the scheme Saber Sauchagar.

Swarnajayanti Gram Swarojgar Yojana / National Rural Livelyhood Mission(SGSY/NRLM):

- 1) Preparation of Data Base is going on.
- 2) Guidelines in respect of NLRM are still waiting.
- 3) It was pointed out that in some cases the site for the Market Complex has been found to be not suitable.

Pradhan Mantri Gram Swarojgar Yojana (PMGSY):

- 1) Problems that stand on the way of implementing the schemes should be brought to the notice of the authority for early solution.
- 2) Tender process of 6(six) road schemes (Chapra : 2, Krishnagar-I : 2, Ranaghat-I : 1, Nakashipara : 1) could not be completed due to poor response. Sabhapatis of the concerned Panchayat Samitis were requested to look into the mater i..e.in sorting out the Executing Agencies for the respective schemes of the Panchayat Samitis immediately.
- 3) Fund in respect of Maintenance of Road has not yet been placed.
- 4) The road scheme : Sibpur Ferry Ghat to Sola Muslimpara under Tehata-I Block has been damaged before hand over. The responsibility lies with the Executing Agency. The Ex. Engineer has to take necessary action.

National Social Assistance Programme (NSAP) :

- 1) Allotment of Fund upto January 2014 has been released.
- 2) The left-out beneficiaries of erst-while NOAPs has been included except for Chakdah, Karimpur-I and Nabadwip. After physical verification pension would be disbursed to the beneficiaries.Action for arrear payment would taken in due course.
- 3) Block wise quota in respect of IGNOAPS will be notified shortly.

RGGVY(Rajiv Gandhi Grameen Vidyutokaran Yojana) :

- 1) There are few problems in implementing the scheme. It was requested to highlight such problems and bring to the notice to the District Magistrate, Nadia personally with sketch map & indicating especially main issues and probable suggestions for early solution etc immediately.


BACKWARD CLASS WELFARE(BCW):

- 1) In reply to a query it was confirmed that land document is not mandatory for caste certificate but the beneficiary has to satisfy the Inquiring Officer regarding his caste. A clarification on this score may be issued shortly.
- 2) It was reported that the Matron / Superintendent does not stay in the hostel in Aranghata Hostel. It was requested for causing field verification, along with the peoples' representatives, of all hostels of the district and put up status report covering all points including security of the hostels. The report should contain photographs of all the hostels.

The representative of the Hon'ble Member of Parliament, 12-Krishnagar PC reminded for field visit by the Monitoring Teams to be constituted with the members of this DLVMC. It was also reported that there was cases of defalcation in Post Office in respect of ICDS & MGNREGS. He assured to provide specific cases in due course. The progress of work of the district was highly appreciated by him.
