In view of ensuing Lok Sabha Election, 2014 sealed tenders are invited from professional & bonafied contractors having experience of work in the field of lighting, generator, installation of fans, supply of public address system etc. for D.C. & R.C., Strong room, Counting halls, Movement Cells etc. The rates of items are to be as per annexure enclosed.

1. Clearance certificate (Up to 31st Jan'2014) of VAT Registration, Professional Tax, Trade License should be attached with tender paper.
2. Credential in same nature of works, if any, should be attached with the Tender Paper.
3. Necessary wire, switches, switch-boards and other electrical materials are to be supplied by the Contractors for this work. All the electrical works are to be done as per Govt. Rules and specification of concerned P.W.D. schedule.
4. Selected tenderers will have to execute agreement in Non - Judicial Stamp pare regarding smooth & timely completion of the assigned work.
5. No charges, other than offered rates will be admissible. No compensation can be claimed for any loss, damage of electrical equipments for the reason whatsoever.
6. Any dislocation, delay, willful negligence will make this office compelled to forfeit the entire claim and also the security deposit without assigning any reason whatsoever & initiate penal action against the defaulting agency as per rules.
7. Last date of application form tender paper is 28.03.2014 up to 2 p.m. along with all above mentioned relevant documents duly attested by competent authority, otherwise Tender will be summarily rejected by the undersigned without showing any cause.
8. The tenderers will have to deposit a sum of Rs. 25000.00/- (Rupees twenty five thousand) only by means of a bank Draft in favour of the Sub - Divisional Officer, Ranaghat Sub - Division, Nadia as earnest money.
9. The entire work will be supervised by the Infrastructure Cell formed for this purpose and if necessary, technical opinion regarding satisfactory completion of works from P.W.D & Fire Brigade authorities may be obtained before making payment.
10. Further information, if any, may be obtained from Nazareth Section under Office of the Sub - Divisional Officer, Ranaghat Sub - Division, Nadia. The tender, quoting the rate both in words and figures should be dropped in the tender box kept in the Office Chamber of the Sub - Divisional Officer, Ranaghat Sub - Division, Nadia on or before 02.04.2014 by 02.00 P.M.
11. The tenders will be opened on the same day i.e. on 02.04.2014 at the Office Chamber of the Sub - Divisional Officer, Ranaghat Sub - Division, Nadia at 03.00 P.M.. The willing tenderers may remain present at the time of opening the tenders.
12. The sealed envelope should be super scribed "Tender for Electrical Works for Lok Sabha Election, 2014". The rate should be quoted in the prescribed tender form
13. No tender will be received by Post. The Sub - Divisional Officer, Ranaghat Sub - Division, Nadia reserves the right to accept or reject any of the tenders without assigning any reason.
