**ORDER**

The following persons are hereby engaged on contract basis to act temporarily as Clerk with Knowledge of Computer Operation under the Labour Commissionerate, West Bengal w.e.f. the date of their joining. Each of them should submit to the reporting officer, a Medical Certificate from a registered medical practitioner to that effect that he/she is physically fit to do his/her duties.

He/she will draw a fixed consolidated initial basic pay of erstwhile Scale No. 6 (ROPA, '98) i.e. Rs.8840/- in the revised pay structure of (ROPA, 2009) plus dearness allowances on the date of engagement under the Head of Account "2230 - Labour and Employment – 01 – Labour – 001 - Direction & Administration – NP – Non Plan – 002 – Enforcement of Minimum Wages for Agricultural Labours-02Wages[LB] – Voted " [ Headcode – 2230 -01 - 001—NP – 002-V-02Wages [LB] - Demand No. 35 ].


This engagement on contract basis is made in terms of Labour Department Order No. 896 – G.E., dtd. 19.5.2014 and earlier Order No. 634- G.E., Dt. 25.3.2010. This engagement is temporary, on contract basis for a period of one (1) year which may be renewed up to three (3) years. However, this contract engagement may be terminated with one month's notice from either side. He/she will be liable to be transferred to any RLO/LWFC in the interest of public service. He/she will execute an agreement for engagement on contract basis as per prescribed proforma.

No travelling allowance for his journey to join the post will be allowed.
