(D) Terms & Conditions

- 1) Separate rate for each of above mentioned items including loading and unloading at District Election Godown should invariably & clearly be mentioned in the letter head pad duly signed by the bidders.
- 2) All Forms should be printed in milky white good quality paper 8.KG. and sample of paper to be used for printing of forms should be submitted with tender papers, duly signed by the tenderers, otherwise the tender paper will be rejected.
- 3) Earnest money of Rs. 10,000/- (Ten thousand) only is to be deposited through bank draft along with the tender papers in favour of District Magistrate, Nadia.
- 4) The prospective bidders may know every details regarding printing of forms poster, flex, sticker colour specification etc. from the District Election Section, Nadia before submission of quotation. No plea of ignorance shall be entertained at any stage of the process.

5) Copy of registration certificate, up to date VAT return copy, Income Tax, Professional Tax clearance certificate, Credential and trade license should be submitted with the tender papers.

6) The tenders should be submitted at the specified box kept at the chamber of the Addl. District Magistrate (Election), Nadia up to 2-00 p.m. on **14/08/2015** in a sealed envelope super scribed as Tender for printing of forms , poster, flex etc. in connection with Tender Notice No 975(14)/Elec. 04/08/2015 and no tenders will be accepted beyond the date and time fixed.

7) The successful bidder has to produce Proof before the authority against each above articles as per work order before final printout of the printing materials without fail.

8) The authority reserves every right to accept or reject all or any of the quotations without assigning any reason whatsoever at any stage and is not bound to accept the lowest rate.

9) All items should be printed and supplied as per specification to be supplied from the District Election Section.

10) All tender will be opened at the office chamber of Addl. District Magistrate (Elec.), Nadia at **4.00 p.m. on 14/08/2015** where the tenderer or his/her duly authorized representatives may remain present.

11) The validity of the tender will be up to 31/12/2016 from the date of issue effect of the tender.
