Tenderer should produce credentials of similar nature of completed works(supply) of the minimum value of 40% of the estimated amount put to tender during 5(five) years prior to the date of issue of this tender notice. Attested copies of Income tax Return for financial year 2013-2014, PAN card, Sales Tax clearance certificate including VAT, trade license, & P.tax are also be produced along with application.
3. Tender paper will be issued to qualified tenderer only.
4. Rate should invariably & clearly mentioned in the letter head pad duly signed by the tenderer. The rate must be quoted in terms of FIGURE & WORDS neatly & correctly in English including loading/unloading, transportation and all other charges. Rate should be less /at per. Above rate shall not be accepted.

5. A sum of Rs.7010/- (Rupees seven thousand ten ) only is to be deposited through Bank draft as Earnest Money in favour of the Assistant Director of Fisheries, Nadia with tender paper. In case of successful tenderer the earnest money will be treated as security deposit and will be refunded after 3 months after supplying the same and unsuccessful tenderer it will be refunded within one month.


