

**GENERAL INSTRUCTION FOR**  
**ENGAGEMENT OF D.E.O IN CMDMP**  
**UNDER SANTIPUR DEVELOPMENT BLOCK.**

- 1) The candidate must note that his/her admission to the Examination is strictly "Provisional".
- 2) The mere fact that the Admit Card has been issued to him/her does not imply that the candidature has been finally cleared by the Selection Committee or that the entries made by the candidate in his/her application for the Examination have been accepted by the Selection Committee as true and correct.
- 3) The candidate must note that the Selection Committee takes up the verification of eligibility conditions i.e. age, educational qualifications, community etc. with reference to original documents only of those candidates who qualify in the written examination.
- 4) The candidate must also note that if subsequent to the issue of Admit Card, ineligibility is detected at any stage before or after the Examination or if the conditions prescribed in the Rules and Instructions given in the advertisement or any other additional information/documents called for at any stage, are not complied with within the time specified therein, the candidature would be rejected.
- 5) Candidate must bring One Photo Identity Proof (Voter Card, PAN Card, Adhaar Card, Bank Pass Book, Passport, Driving License) along with him/her.
- 6) Candidate must bring 01 (one) color passport size photograph of own.
- 7) Travelling and other expenses must be borne by the candidate himself/ herself.

**INSTRUCTIONS DURING THE WRITTEN EXAMINATION**  
**FOR ENGAGEMENT OF D.E.O IN CMDMP UNDER**  
**SANTIPUR DEVELOPMENT BLOCK.**

- a) Written exam will be consisting of 50 questions carrying 1 number for each.
- b) There will be Math, General Awareness Computer Related Questions.
- c) Answer should be made in O.M.R Sheet in Black/Blue Ball point pen only.
- d) There will be four alternatives for the answers to every question.
- e) For each question for which a wrong answer has been given by the candidate, one fourth (0.25) of the marks assigned to that question will be deducted as penalty.
- f) Candidates must mark the answers with their own hand and in no circumstances will they be allowed the help of a scribe to mark answers for them.
- g) If a candidate gives more than one answer, it will be treated as a wrong answer, even if one of the given answers happens to be correct and there will be same penalty as above for that question.
- h) If it is left blank i.e. no answer is given by the candidate, there will be no penalty for that question.
- i) Rough worksheets will be provided to the candidates on demand.
- j) Candidates will not be allowed to mark any answer after the ending bell rings.
- k) Candidates should not carry any books, paper, mobile phone or any other electronic item to the examination venue. Selection Committee will not be responsible for the safekeeping of such item(s).
- l) Impersonation (to assume the identity of another with intent to deceive) is forbidden.
- m) Candidates must not, on any pretext whatsoever speak to or have any communication with any other Candidates. Such communication will be regarded as a breach of the Examination Rules.
- n) Candidate in the Examination venue, who is found to have unauthorized materials in his/her possession, shall be deemed to have indulged in breach of the Examination Rules.
- o) Any breach of Examination Rules shall be considered to constitute unfair practice. In case any candidate is found to be indulging in unfair practice, he will be liable to be debarred from this Tests/Exam.
- p) At the conclusion of the Examination, candidates must remain seated quietly and must not communicate with one another till the Examination is over.
- q) No candidate shall be permitted to leave Examination Hall before expiry of the allotted time.
- r) The candidate must abide by the instructions and such further instructions as may be given by Supervisor/Invigilator of the Examination. If the candidate fails to do so or indulges in disorderly or improper conduct, he/she will render himself/herself liable to expulsion from the Examination and/or such other punishment as the Selection Committee may deem fit to impose.
- s) The candidate will furnish correct information as may be required from him/her in the Examination Hall by the Invigilator/Assistant Supervisor/Supervisor/other persons so authorized by the Selection Committee.
